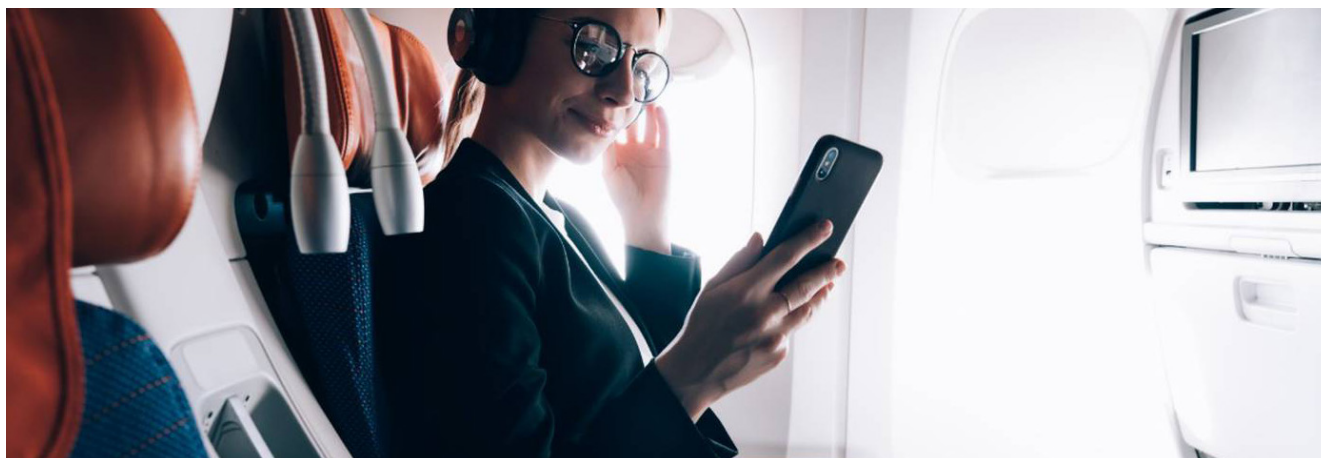


# Corporate Travel Insurance



Chase corporate travel insurance provides cover for employees travelling for business purposes and is designed to cover almost any incident, at the same time protecting business interests and employee well-being.

Managing the risk associated with employees travelling internationally can be particularly challenging. Even a minor health or security issue, if left unchecked, can quickly escalate into a serious problem.

Chase corporate travel insurance provides employees with immediate access to 24-hour, 365 days emergency assistance so you can be rest assured that your employees will be well taken care of.

## Chase corporate travel insurance covers

- » Directors, employees, consultants, contractors and sub-contractors undertaking work on behalf of the business and associated leisure travel
- » Pure leisure travel for directors, chief executive officers, chief financial officers, chief operating officers, company secretaries and general managers, their accompanying spouses or partners and/or dependent children involving an overnight stay or aerial flight.

## Corporate travel insurance highlights

- » Personal accident and sickness – Includes weekly benefits due to sickness or injury as well as accidental death and other lump sum capital benefits
- » Kidnap, ransom, extortion, hijack and detention benefits
- » Overseas medical expenses and medical evacuation expenses – Overseas medical and emergency evacuation expenses, including a daily cash benefit when confined to bed for a period greater than 24 hours (up to 90 years of age)
- » Travel disruption – Includes missed connection, loss of deposits, cancellation and curtailment and alternative employee or resumption of assignment benefit
- » Baggage, portable electronic equipment and money – Includes loss of money and travel documents as well as deprivation of baggage cover
- » Corporate protection – Benefits include corporate image protection, repatriation and funeral expenses and staff recruitment benefits
- » Rental vehicle excess waiver – Covers the excess payable in the event of loss or damage to a rental vehicle
- » Personal liability
- » Extra territorial workers compensation – Cover for differences in workers compensation entitlements when employees are travelling inter-state within Australia
- » Political unrest and natural disaster evacuation – Evacuation to the nearest place of safety in the case of political unrest and/or a natural disaster.
- » Search and rescue expenses – Reimbursement of expenses relating to search and rescue of a missing insured person
- » Personal wellbeing – A range of additional benefits including accidental HIV infection, rehabilitation and financial advice benefits
- » Unlimited access to Fullerton Emergency Assistance.

## Fullerton Emergency Assistance

In an emergency, you need reassurance and an immediate response. Travellers have unlimited access to Fullerton Emergency Assistance. This includes:

- » 24/7 access to a team of medical practitioners for emergency assistance and advice
- » arranging emergency medical evacuations due to injury or sickness including medical escorts
- » arranging for accompanying persons to travel with and/or remain with travellers who have suffered an injury or sickness
- » the remittance of payment guarantees and insurance verification to hospitals
- » repatriation of travellers to a more suitable medical facility or back to their country of residence after suffering an injury or sickness; and
- » medical monitoring.
